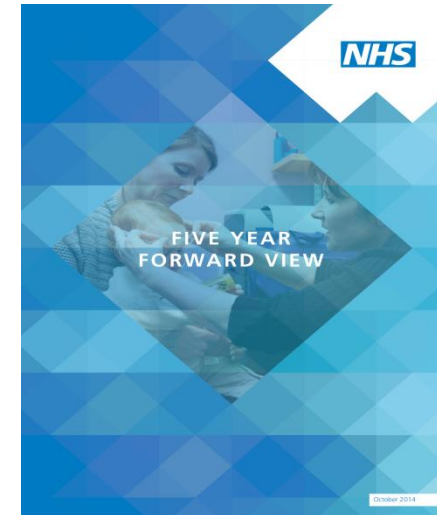

The NHS landscape

- *NHS Five Year Forward View*

- Demands NHS action on four fronts:
 - Do more to tackle the root causes of ill health
 - Give patients more control of their own care
 - Adapt to meet challenge of an ageing population
 - Develop new models of care
- Sets some exciting challenges for property:
 - Unlock assets to reinvest in more modern healthcare
 - Allow GPs to join forces to provide services usually provided in hospital
 - Integrate GP, hospital services, mental health, community and social care
 - Move to a 24 hour, seven day a week NHS



Primary Medical Care: priorities

General practice, with its registered list and everyone having access to a family doctor, is one of the great strengths of the NHS, but is under severe strain. Delivering the New Deal for Primary Care set out in the FYFV will be critical to tackling these challenges.

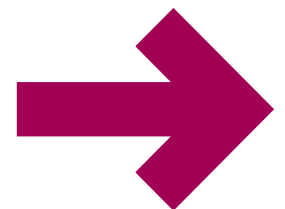

Projects addressing these

- Improve access including PM Challenge Fund – supporting new ways of working and demonstrating new forms of access
- Preparing for peaks in demand
- Stabilise core funding for general practice nationally over the next two years while an independent review is undertaken of how resources are fairly made available to primary care in different areas
- Co-commissioning to give CCGs more influence over the wider NHS budget, enabling a shift in investment from acute to primary and community services
- Deliver the 10 point Plan. The key elements are:
 - Recruit newly trained doctors into general practice
 - Retain GPs
 - Encourage doctors to return to general practice
- Develop multi-disciplinary primary care workforce; link to CCG role on community workforce
- Roll out Primary Care Transformation Fund to accelerate investments in GP premises and the better use of technology
- The FYFV Vanguard work will accelerate and enable new delivery models
- CQC inspections regime
- Primary care web tool development and GP scorecard
- GP Patient Survey

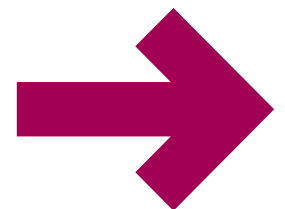
Primary Care Infrastructure Fund

- Announced by Government in December 2014, launched by NHS England in January 2015
- £1bn over four years
- Response to immediate need and enable service innovation
- Infrastructure = premises AND technology
- Create capacity in primary care and access to a wider range of services to help patients maintain their health and stay out of hospital



Estate as a facilitator of change

- **There has been little real attention given to how the NHS estate could help to improve efficiency** - move more care out of hospitals and exploit new technologies.
- **Urgent requirement to do things differently** - modernising service provision; moving to true integration, providers working together to use the estate in a more integrated way.
- **Strategic Estates Planning process will help flush out the requirements** & the need to **offer new ways** of responding to key issues

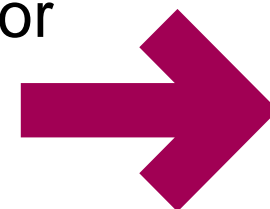

Primary Care Transformation Fund Opportunities for the future

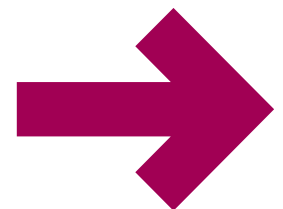
Announced 27 October – next three years
PCTF proposals should:

- Improve 7 day access to effective care
- Increase capacity of primary care
- Enable access to wider range of services to reduce unplanned admissions to hospital
- Increase training capacity in general practice

To form a 3 year programme ending 31 March 2019

Premises schemes should be identified in CCG Local Estates Strategies, which in turn, reflect commissioning intentions

We are seeking additional flexibilities to support a wider variety of schemes.



Stages of the process

1. Guidance available by end December
2. Submission of proposals by CCGs 29 February 2016
3. Assessment in principle by NHS England
4. Announcement of bids approved in principle by NHS England
5. Ongoing approval process
