Statins are in short supply across the country with pharmacists facing a 'desperate' struggle to obtain the life-saving drugs.

Almost eight million Britons rely on statins to lower their cholesterol levels, which in turn reduce the risk of heart attacks and strokes.

But atorvastatin, the most popular statin prescribed by the **NHS**, is missing from many chemists nationwide.





#### LloydsPharmacy ceases operating 90% of branches in 18 months

Exclusive: LloydsPharmacy is running 138 pharmacies in October 2023, compared with 1,338 pharmacies in March 2022, General Pharmaceutical Council figures show.





#### Lloyds Pharmacy

- 1997 bought by Celesio (owned AAH)
- 2014 McKesson bought Celesio for £5.1bn
- 2015 McKesson paid £125m for 281 Sainsbury Pharmacies
- 2022 Aurelius bought Lloyds & AAH for £477m
- 2023 sold or closed 90% of the pharmacies. All ex-Sainsbury pharmacies closed.





Chronic underfunding of the community pharmacy sector has continued to take its toll, with a net loss of 295 pharmacies across Great Britain since <u>our previous analysis</u> in March 2022. The <u>number of community pharmacies in England has fallen for the fifth consecutive year</u>.

Underlying these net figures is a shift in ownership from large multiples to small multiples and independents, mainly down to the sale or closure of most LloydsPharmacy's branches.


Between March 2022 and October 2023, there was a net fall of 1,058 pharmacies among the large multiples, whereas small multiples have gained 195 pharmacies and independents have gained 568 pharmacies (see Figure 1). Small multiples have seen the largest shift in market share, from 13.2% in March 2022 to 17.0% in October 2023.

Figure 1: Large multiples now make up only 38% of the market Count of pharmacies by category, October 2023.



Community pharmacists were initially not included in a life assurance scheme for healthcare staff, excluded from a national PPE ordering system, and not included in a visa extension scheme.




